# Statutes of the Association of Iranian Monarchists in Finland (Shähjar Ry)

- 1. Article Name of the Association:
  - 1.1.The Association of Iranian Monarchists in Finland (Shähjar Ry)
- 2. Article Nature of the Association:
  - 2.1.The Association of Iranian Monarchists in Finland is a non-profit, neutral, and independent organization established to promote Iran's national values, support the institution of monarchy, and defend the aspirations of the Iranian people and the legacy of the Pahlavi monarchy.
- 3. Article Political Principles and Leadership:
  - 3.1. The association recognizes the political leadership of His Majesty Reza Shah II and follows his policies, principles, and views.
  - 3.2.All activities of the association aim to promote the values and objectives defined by His Majesty for the freedom, development, and unity of the Iranian people. These include secularism, democracy, Iran's territorial integrity, and respect for the United Nations Universal Declaration of Human Rights.

- 4. Article Objectives of the Association:
  - 4.1.Increase historical, political, and cultural awareness about Iran's monarchy and its role in the country's development.
  - 4.2.Create connections and strengthen solidarity among pro-Pahlavi Iranians in Finland.
  - 4.3. Organize cultural, political, and social events presenting the monarchist movement to the immigrant community.
  - 4.4. Support global efforts for the restoration of Iran's monarchy.
  - 4.5.Oppose negative and incorrect propaganda against the monarchist movement and the leadership of His Majesty Reza Shah II.
- 5. Article Membership in the Association:
  - 5.1. Membership is open to all Iranians residing in Finland who commit to the association's principles and objectives.
  - 5.2.Official membership requires the completion of an application and acceptance of these statutes.
  - 5.3. Members commit to adhering to ethical principles, cooperating, and supporting the association's programs.
  - 5.4. Voting rights and active participation in decision-making are granted only to official members.
- 6. Article Organizational Bodies of the Association:
  - 6.1. General Assembly:
    - 6.1.1. The highest decision-making body of the association, convening annually.
    - 6.1.2. Responsible for electing board members, approving programs, and evaluating the association's activities.

## 6.2.Board Members:

- 6.2.1. Consist of five regular members and two alternate members elected by the General Assembly for a two-year term.
- 6.2.2. Responsible for leading and planning the activities of the association.

#### 6.3. Auditor:

6.3.1. Oversee the board's activities and financial affairs and presents an annual report to the General Assembly.

## 7. Article – Financial Resources:

- 7.1.Membership fees, determined annually by the General Assembly.
- 7.2. Voluntary donations from members and supporters of the association.
- 7.3. Revenue from events and occasions organized by the association.
- 7.4. Grants from institutions and organizations whose objectives align with those of the association.

# 8. Article - Activities:

- 8.1.Organize meetings, lectures, and discussions on themes related to Iran's history and monarchy.
- 8.2.Establish research groups and publish articles, books, and other materials related to monarchism and the views of His Majesty Reza Shah II.
- 8.3. Organize national celebrations such as Nowruz, Mehregan, and Iran's National Monarchy Day.

- 8.4.Cooperate with other European and international monarchist and freedom movements.
- 9. Article Dissolution of the Association:
  - 9.1. The decision to dissolve the association requires the consent of at least two-thirds of the members present at the General Assembly.
  - 9.2.Upon dissolution, the association's funds will be used for objectives promoting monarchism and the principles of His Majesty Reza Shah II.
- 10. Article Amendment of the Statutes:
  - 10.1. Proposed amendments must be submitted to the board at least two weeks prior to the General Assembly.
  - 10.2. Amendments require a two-thirds majority of the votes of the members present at the General Assembly.
- 11. Article Final Provisions:
  - 11.1. These statutes, comprising 11 articles, come into effect upon approval by the founding General Assembly of the association.
